GROUP WATERFRONT POLICY AND AGREEMENT

In order to insure adequate supervision for any persons engaging in waterfront activities and to protect the waterfront equipment, the following policies have been adopted and are to be followed:

If in the opinion of the Resident Manager or Summer Camp Director, there is insufficient or inadequate adult supervision, the group's privilege of using waterfront – either watercraft or swimming – may be suspended IMMEDIATELY.

•**USE OF CAMP WATERCRAFT:** Any picnic, camping or retreat group wishing to use the camp watercraft must check in with the camp resident manager upon arrival to review safety rules. ***Proper adult supervisions is required at all times.** At the conclusion of their waterfront time, the group will check out with the resident manager who will see that all equipment has been properly stored and is in good condition. The group will be responsible to pay for any equipment that was damaged. Life jackets must be worn by all watercraft users. We also recommend a “checkout” system be used to identify the participants, the equipment in use, the approximate area of use and the time of return.

*LOMIK - Lutheran Outdoor Ministries Indiana-Kentucky recommends that “proper adult supervision” be a certified lifeguard with current certification from a nationally recognized training provider (e.g. American Red Cross, YMCA) who also holds certification in First Aid (with training on blood-borne pathogens) and age-appropriate CPR (with training in use of AED and breathing devices)

USE OF PRIVATE WATERCRAFT: Any picnic, camping or retreat group wishing to use privately-owned watercraft must check with the camp resident manager prior to arrival. ***Proper adult supervision is required at all times.**

•**SWIMMING:** Any picnic, camping or retreat group wishing to swim in camp facilities much check in with the camp resident manager upon arrival to review safety rules. Each group will assume responsibility for their own members during swimming as the camp cannot provide any lifeguard personnel. No lake swimming after dark. ***Proper adult supervision is required at all times.** (Use of the pool at Lutheran Hills is from three (3) days prior to the first day of summer camp to the Sunday after the last day of summer camp.)

If your group intends to make use of any waterfront activity during your stay at Lake Luther, Lutheran Hills or Lutherwald, please complete the section below and return it to the LOMIK office. Your group must have completed and filed a reservation form prior to your stay to utilize the waterfront.
