Campground Rules

Camparound

Register. Overnight and day visitors must register each visit upon entering the campground and pay appropriate fees. All fees are paid by envelopes found in the Registration Hut at the camp entrance. No one under 18 is permitted to camp without their parents or adult chaperone in the campground.

Be Considerate of Others. Observe a general quiet time of 11:00 p.m. – 7:00 a.m. Keep music, radio, TV volumes low at all hours. Fireworks are prohibited at all times.

Pets. Keep dogs quiet and LEASHED AT ALL TIMES. All pet messes are to be cleaned up by the owner. Pets are not allowed in any building or past the gate in the swimming beach area.

Alcohol Policy. The discreet, legal use of alcohol at your campsite is permitted. DRUNKENESS AND LOUD PARTYING WILL NOT BE TOLERATED. <u>Absolutely no alcohol in public locations, including the beach!</u>

Slow Down. Observe the camp property speed limit of 15 mph.

Campfires. Supervise all campfires. Firewood may be purchased (\$5 per load) at the shelter across from the Campfire Circle along the road to the beach, or at the bathhouse.

Trees. Do not cut down or trim trees without permission. Do not nail or screw any item into any tree. Trees on this property are harvested, nails destroy a tree's value and pose potential danger to workers and the trees.

Dispose Trash Properly. Dispose of all garbage and trash in the dumpster located at the maintenance shop building. Do not put personal trash in the bathhouse. Dispose of all sewage and gray water in the dump station located in front of the bathhouse. Recycling whenever possible is highly encouraged. Instructions are on the recycling shed in the maintenance shop area.

Prohibited. Firearms, fireworks, illegal drugs.

Jim has authority to revoke any and all camping privileges at his discretion.

Golf Carts. Children who are not licensed may not drive a golf cart without a supervising adult in the cart with them.

Boating

Launch. Only boats that are human, wind, or electric powered may be launched from camp property. All boats are launched in the family camp boat docking area only and not from the swim area. Do not launch a boat if it has been in other bodies of water during the last 3 days. (We must prevent the spread of zebra mussels into our lake.)

Camp Boat Usage. You are welcome to use LOMIK kayaks, rowboats and canoes (located at the swimming beach) when youth camp activities are not in session. Please return our boats on the racks at the sides of the swim area. Do not use other boats, as they are privately owned and cannot be used without owners' permission.

Storage. Keep ALL boats and/or trailers in boat dock area only. (Do not store them at campsites or in the family camping area.) Stored boats must be marked with owner's name. No pontoons and ski boats are to be left behind at camp when owner is not present.

Lifejackets. Everyone in a boat or canoe must have an approved floatation device with them, as this is required by Indiana State law.

Swimming Beach

Swim Safely. Swim at your own risk – usually NO LIFEGAURD is on duty. Do not swim alone. Children under age 16 must have an adult at the waterfront with them. When lifeguards are present during summer camp swim time, all swimmers (including family campground members and visitors) must follow their direction.

Clean Up. Return all watercraft and equipment to the proper storage areas. Remove all trash from the beach.

Follow Rules. No fishing in the swimming beach area at any time. No pets past the gate to the swim area. No fishing, vehicles, fires, cooking, alcoholic beverages or camping at the beach are
